#### **TERMS & CONDITIONS**

Payment – An invoice will be created upon receipt of this signed agreement and should be paid within 14 days of being received. Benefits will ensue upon receipt of payment.

Limited Liability – The liability of ADMEI for any act, error, or omission for which it may be held legally responsible shall not exceed the cost of any cash payment. ADMEI will not, in any event, be liable for consequential damages, including, but not limited to, lost income or profits. ADMEI shall not be subject to any liability whatsoever for any failure to hold event because of an act of God, outbreak of hostilities, insurrection, riot, civil disturbance, terrorism, government act or regulation, pandemic, fire, flood, explosion, accident, theft, or any other cause beyond the reasonable control of ADMEI. Unintentional or inadvertent failures of either party to print, publish, or circulate the other party's name and/or materials shall not be considered a breach of the Agreement.

**General Terms** – The terms and conditions set forth in this Agreement govern the relationship between ADMEI and Sponsor. This Agreement is nonexclusive and does not constitute an endorsement by ADMEI or its representatives of the Sponsor's products. Unless expressly agreed to in writing by ADMEI, no other terms or conditions appearing in contracts, orders, insertion instructions, or otherwise that conflict with the provisions of this Agreement shall be binding on ADMEI. ADMEI shall not be bound by conditions printed or appearing on order blanks or copy instructions that conflict with provisions of this Agreement. The waiver of any provision of this Agreement shall not be construed to a waiver of either party's right to later require strict observation and performance of each of the provisions hereof. Facsimile or electronic transmission of a copy of this Agreement bearing a signature shall be deemed delivery of a signed original Agreement.

Severability – If any section or provision of this Agreement is deemed illegal by a competent court of law, all other provisions of this Agreement shall remain in force.

**Entire Agreement** – This Agreement constitutes the entire agreement between Sponsor and ADMEI. No modification or amendment to this Agreement shall be effective unless made in writing and signed or acknowledged by the party to be bound. Sponsorship levels and pricing are accurate at the time of printing this document. ADMEI reserves the right to modify sponsorship levels, pricing, or conference at any time.
